

LOCATION

Strachur is located in the Cowal peninsula which is situated between Loch Long to the east and Loch Fyne to the west and bordered by the arterial road A83. Strachur is 7 miles south of the A83, linking Loch Lomond to Inveraray, Lochgilphead and Campbeltown, and is 18 miles north of Dunoon, the main town of the Cowal peninsula. Also, there is a regular bus service between Dunoon and Inveraray. The village of Strachur has a post office, 2 churches, a primary school, a hotel/bar and a local bar. The property sits just off the A815 behind the Fire Station.



DESCRIPTION


Single brick/roughcast single storey house with incorporated office area. 3 single garages. Large gardens to front and rear of the property. Built circa 1962.

Living Room




Main bathroom
